1. Scope. These General Terms and Conditions ("Terms") are applicable to all customers (the "Customers" and each, individually, a "Customer") of Gubelin Gem Lab Ltd. ("Gubelin"), a Hong Kong company limited by shares for gemmological analyses or similar services (the "Services").

Transportation and Insurance

2. Iransportation and insurance. All diamonds, gemstones, pearls, is wellery and other items ("Gemstones") may be delivered to Gube-lin in Hong Kong at Customer's risk via courier service or registered mail or other means of transport at the election of Customer. Any and all Gemstones sent to Gubelin shall be insured by Customer to the feature of the second se at the election or Customer. Any and all Genstones sent to Gubelin shall be insured by Customer to their full value, such insurance covering the delivery to Gubelin, the time period during which the Genstones are at the laboratory and the return of such Genstones by Gubelin to Customer. Customer is solely responsible for and shall arrange the completion of all formalities with respect to the import and export of Genstones into and out of Hong Kong and the payment of all import and other duties. Gubelin shall not accept any Genstones for which import, export and customs formalities have not been completed. been completed

3. Fees and Conditions of Payment. The fees for Gubelin's Services shall be governed by Gubelin's pricing schedule in effect at the time of the placement and acceptance of any order. The pricing schedule shall be provided to Customers upon request. Invoices for Services rendered become due with the completion of the Services and shall be paid by wire transfer within 30 days of the invoice date.

Gubelin reserves the right to demand payment prior to delivery of any Gemmological Reports ("Reports") and Services. New customers are required to provide payment in advance of the performance of any work.

4. Delivery Deadlines.

5. Scope of Services and Report. Gubelin shall deliver to Customer a physical and / or digital Report or other documents reflecting the results of Gubelin's examination of the Gemstones provided to Gubelin.

Only the original Report shall be considered by the Customer as representing the results obtained by Gubelin during its examination. The signatures featured in the Report may be facsimiles. Such facsimile signatures have no effect on the validity of the Report. Gubelin staff whose signatures are featured in the Report have personally examined the titem and/or reviewed the analytical data relating to the item, as obtained by other Gubelin staff. Photographs of Gemstones serve solely as a representa-tion of the serve the serve solely as a representation of the examined Gemstones and may differ in appearance from the original Gemstones

The results contained in the Report shall be limited to a selection of identified characteristics, which were ascertained during the examination of the Gemstones in accordance with the scientific standards current at the time of the examination. It is possible that a later re-examination of the Gemstones may lead to different results, should the applicable scientific standards for the examination change subsequent to the examination of the Gemstones by Gubelin.

Voluntary disclosure of client's name: upon specific request by the client, Gübelin adds a comment on the Report disclosing the name of the client who presented the stone to Gübelin for testing. The mention of the client's name on the report does not imply any evidence regarding the ownership of the stone, nor does it provide any reliable information on the possible provenance or supply chain of the stone.

Verbal Opinion and GemCard.** For some gemstones a preliminary verbal opinion is possible based on a short analysis. This so-called "Verbal" is a non-binding, non-committal and informal opinion of the gemmologist on a very lim-ited basis of analytical indications. If the client requests a Verbal, Gubelin contacts the client be-fore performing the full analysis, giving the client the option of stopping the analytical process, based on this preliminary information. The Verbal might differ from the final result on the Report. In such a case, the standard price for the full service will be charged. Gubelin is not always in the position to give a Verbal on an item. The client is obliged to pay the cost for the Verbal service, re-gardless of the completeness and accuracy of this preliminary information. The Gubelin GemCard is a preliminary, informal, incomplete and non-binding conclusion of the analysis performed on a client item and is handed out to the client on paper, filled in handwriting by a Gubelin Gem Lab employee. The GemCard is only handed out personally on Off-Premises-Testing (OPT) or fairs and is not sent to the client, neither in hard copy nor electronically. The GemCard contains limited information on the conclusion of the analysis performed on the item and does not replace the formal Gubelin Gem Lab ke-port, which is the only fully reliable report document. The GemCard is not subjected to the standard quality control procedure performed on Reports and thus, information on the GemCard in gibt differ from the information stated on the later issued Report. 7. Origin of Gemstones.

7. Origin of Gemstones. A professional opinion regarding the probable geographic origin of a Gemstone may be given whenever possible and upon request by the Customer. Information concerning the geographic origin of a Gemstone is based on comparisons of internal characteristics, physical and chemical characteristics with the characteristics of reference stones of known identity, the results of continuing scientific research of Gubelin and published gemmological findings. Gubelin's opinion concerning geographical origin of a Gemstone. Designations of geographic origin are expressions of opinion based on known facts and scientific observations but Gubelin makes no warranty whatsoever regarding the actual origin of any Gemetrone. 8. Explanations with Respect to the Treatment and Handling of Gemstones. In accordance with internationally accepted standards, Gubelin may not mention all types of treat-ments that may have been applied to or used with respect to the Gemstones under examination. The fact that a particular method or treatment is not specifically mentioned in a Report does not mean that such treatments or methods were not used with respect to the particular Gemstone. Any remarks concerning the presence or absence of any treatment type or method are solely the expression of the findings made by Gubelin.

9. Identification, Grading and Treatment of Diamonds. Gubelin only grades diamonds which have been determined to be natural. Synthetic (aka lab-grown) diamonds will be identified as such but will not be graded by quality grades. Symbols used in cut sketches show the approximate size, type, number and location of internal and external characteristics of the examined diamond. If significant characteristics are present, smaller external characteristics as well as minute inclusions may not be included in the sketch. Enhancements to the clarity or coloration of a partner diamond will be particuled in the Rancet. Humans in such a magnetic well as readed natural diamond will be mentioned in the Report. However, its quality will not necessarily be graded.

Gubelin notes that certain treatment methods used on diamonds are difficult to detect or can only be detected under very specific circumstratenes. Accordingly, Gubelin makes no warranty whatsower that the analysis performed by Gubelin has revealed all treatments to which a diamond has been subjected whatsoever that

10. Analysis of Precious Metals. On demand of the customer precious metals are analysed by LA-ICP-MS (see below). Gold (Au), sil-ver (Ag), copper (Cu), platinum (Pt), palladium (Pd), zinc (Zn), nickel (Ni), lead (Pb), rhodium (Rh), manganese (Mn), iron (Fe), tin (Sn), arsenic (As) and antimony (Sb) are quantitatively analysed. The precious metal alloys are classified according to guidelines proposed by the "Convention on the Con-trol and Marking of Articles of Precious Metals" (Annexes 1 and II), which is adopted by the "Confed-eration International de la Bijouterie, Joaillerie, Orfeverie, des Diamants, Perles et Pierres" (CIBJO).

11. Jewellery Passport and Gemstone Rating. Gübelin Gem Lab Jewellery Passports are issued for jewellery items containing multiple gemstones, typically of different types. The Gübelin Gemstone Rating on the other hand intends to express the quality, ratiry and saliency of a specific gemstone in a number. Both services are issued on the basis of a different, reduced standard of analysis as is applied on other Gübelin Gem Lab services. Thus Jewellery Darsports and the Gemstone Rating are not subject to the same level of scrutiny as Gübelin Gemmolog-ical Reports. It is important to understand that Gübelin Jewellery Passports and the Gemstone Rating do not comply with the standards specified by the Gübelin Gem Lab Seal. These two services differ from Gemmological Reports with regards to the depth, breadth, details and numbers of analyses. The detail of disclosure – specifically regarding authenticity and treatments – used in Jewellery Passports and the Gemstone Rating is also limited and simplified compared to Gemmological Reports. Owed to this reduced level of analysis and disclosure, the findings stated in a Jewellery Passport or the Gemstone Rating might not be consistent with the findings stated in a Gübelin Gemmological Report for the same item.

12. Scientific Research. All data, including but not limited to gemmological, geological or chemical data, which is gathered during the analysis of any Gemstones remains the sole property of Gubelin and may be freely used for scientific or commercial research purposes by Gubelin.

13. Acceptance of Services.

Orders processed by Gubelin shall be examined by the Customer within five (5) business days beginning on the date of delivery to the Customer. The Services and Gubelin's work products shall be deemed to be accepted unless a written notice describing the deficiency is received by Gubelin within the applicable time period set forth above.

The analyses that Gubelin applies include non-destructive and, if required, quasi non-destructive analytical methods, such as Laser Ablation-Inductively Coupled Plasma-Mass Spectrometry (LA-ICP-MS). This method evaporates minute amounts from the girdle (whenever possible) by means of a laser beam. The LA-ICP-MS analysis creates a small pit with a diameter of, typically, 0.08 mm and a depth of approximately 0.005 - 0.010 mm. These pits are hardly visible by 10x magnification, and the loss of weight is below 0.001 ct and can thus not be detected by any gemmological weight balance. The LA-ICP-MS analysis does not affect the quality or visual appearance of the gemstone.

14. Affiliated Companies, Subcontractors and other Auxiliaries. The Customer agrees to Gubelin having works, including, but not limited to handling, testing, analys-ing, unmounting and mounting of the Gemstone, done by affiliated companies, subcontractors or other auxiliaries. Furthermore, the Customer agrees that regardless of the place of submission of the stone, the service or parts of the service might be carried out by other Gübelin Gem Lab facilities. This implies the acceptance of the shipment of items by professional shipping companies.

Client has the option to commissions Gubelin to carry out unmounting / remounting services. Client accepts after signature of this agreement that Gubelin is not liable for any damage which might occur to the genstones, pearls or jewellery during the unmounting or remounting process. All risk of potential damage to the genstones, pearls or jewellery is borne exclusively by the client.

Gubelin assures that the unmounting / remounting services are conducted by experienced and trained professionals only

15. Warranty and Liability.

Gubelin shall not be liable under any circumstances to Customer or any other person if (a) the Services Guiden shart not be native finded any ercentistic stoce of the services are not used for the intended purpose; (b) any Report prepared by Gubelin was subsequently modified without Gubelin's written consent or (c) the Customer should not have disclosed to Gubelin all material facts known to the Customer with respect to the Genstone analysed.

EXCEPT FOR THE WARRANTIES SET FORTH IN THIS SECTION 14, GUBELIN MAKES NO OTHER WARRANTIES, EITHER EXPRESS OR IMPLIED, WITH RESPECT TO THE SER-VICES BY GUBELIN OR ANY OF ITS AGENTS OR SUBCONTRACTORS. ANY AND ALL WARRANTIES, INCLUDING WITHOUT LIMITATION, WARRANTIES OF MERCHANT-ABILITY OR FITNESS FOR A PARTICULAR PURPOSE, ARE EXPRESSLY EXCLUDED AND DECLINED.

CUSTOMER MAY NOT BRING ANY ACTION ARISING OUT OF OR IN CONNECTION WITH ANY TRANSACTION COVERED BY THESE TERMS UNLESS SUCH ACTION IS COM-MENCED WITHIN SIX MONTHS AFTER THE CAUSE OF ACTION HAS ACCRUED.

THE LIABILITY OF GUBELIN HEREUNDER IS EXPRESSLY LIMITED TO DIRECT DAMAG-ES DUE TO GROSS NEGLIGENCE AND WILLFUL BEHAVIOUR INCURRED WITH RESPECT TO THE SERVICES BY GUBELIN. IN NO EVENT SHALL GUBELIN BE LIABLE TO ANY PER-SON FOR ANY INDRECT, SPECIAL, EXEMPLARY, PUNITIVE, INCIDENTAL OR CONSE-QUENTIAL DAMAGES INCLUDING BUT NOT LIMITED TO LOSS OF PROFITS OR GOOD-WILL, OR ADDITIONAL EXPENSES INCURRED, WHETHER PURSUANT TO A CLAIM IN CONTRACT, TORT OR OTHERWISE AND WHETHER IN AN ACTION FOR BREACH OF WARRANTY OR OTHERWISE.

GUBELIN IS NOT LIABLE FOR ANY LOSS OF OR DAMAGE TO THE GEMSTONE DUE TO NEGLIGENT OR WILLFUL BEHAVIOUR OF A SUBCONTRACTOR OR OTHER AUXILIARY (pursuant to #13).

16. Copyright and Other Intellectual Property Rights. All Gubelin's patents, trade secrets, copyrights, trade names, trademarks, service marks, proprietary materials, methods, processes, know-how or other intellectual property and all improvements to any of the foregoing (collectively "Gubelin Property") used in connection with the Services shall remain the sole and exclusive property of Gubelin, and Customer's rights to use such Gubelin Property shall be limited to those permitted by these Terms. Any Gubelin Property or improvements thereto which are used, improved, modified or developed by Gubelin at any time shall be the sole and exclusive property of Gubelin hereby grants the Customer a royalty-free, non-transferable, non-exclusive license to use Gubelin Property solely in connection with the use of any Report created as part of the Services. of the Services.

The Customer agrees that Gubelin may publish photos of the gemstone for which Gubelin has pre-pared a report in its folders, brochures, other publications and on its website, provided, however, that the identity of the owner of the gemstone is not mentioned.

Payment Default

If Customer fails to pay any invoice for Services provided by Gubelin in whole or in part on or before In customer tans to pay any involte for services provided by Gubelin in while of it part of before the date required, Customer shall pay interest to Gubelin at the rate of five (5) percent per year. The specification or charging of interest shall not be deemed an agreement to extend credit. If a Customer fails to pay any invoice for services provided by Gubelin in whole or in part for more than thirty (30) days, Gubelin may refuse to complete orders which have been, or will be, placed with Gubelin until such outstanding amounts and any interest on such outstanding amounts owing to Gubelin have been paid in full. Notwithstanding the foregoing, Gubelin shall be entitled all other available remedies at law or in equity.

18. Governing Law and Jurisdiction; Place of Performance. THE CONSTRUCTION AND VALIDITY OF THESE TERMS SHALL BE GOVERNED BY THE LAWS OF HONG KONG, REGARDLESS OF WHERE ANY ORDER WAS PLACED OR FILED, THE PLACE OF PERFORMANCE OF THE SERVICES OR DELIVERY OF REPORTS OR WHERE ANY OTHER ACT OR PERFORMANCE OCCURRED.

THE CUSTOMER AGREES TO THE EXCLUSIVE JURISDICTION OF THE COURTS LOCAT-ED IN HONG KONG, WITH RESPECT TO ANY AND ALL DISPUTES ARISING OUT OF OR IN CONNECTION WITH THE SERVICES RENDERED BY GUBELIN.

19. Revisions

Gubelin may change, revise, amend or modify these Terms from time to time. Gubelin shall provide Customers with written notice of any such changes, revisions, amendments or modifications, provid-ed, however, that any such changes, revisions, amendments or modifications shall become effective without any further action by any party and that they shall not apply to any orders placed and accepted prior to the effective date of such changes, revisions, amendments or modifications.

20. Entire Agreement; Modifications or Waivers. These Terms shall be the complete and exclusive statement of the agreement between the parties with respect to the subject matter hereof and supersede any oral or written communications, understandings, acknowledgements or representations or agreements relating thereto.
